## New Business

How to Encourage Contributions for Central Office

- Contributions slowed in summer months, though are picking back up; there are many ways to contribute: Central Office Backer (individual or meeting) is \$25/year though that price point and overall program is to be reviewed as inflation has risen since that price point was decided on
- November is Gratitude Month; may pass around a second contributions envelope for Gratitude Month
  - Motion to provide manilla envelopes passes with substantial unanimity (one abstention)

Payroll Raises for Central Office Employees

- Consideration of wage increases for Tradition Eight workers, in step with inflation and increased costs of living; most recent wage increase for employees may predate previous manager's tenure (~7 years or more); 1 General Manager (currently \$15/hour) and 2 Assistant Managers (currently \$11/hour)
  - Motion to create an ad hoc committee to explore pay raise options for employees passes with substantial unanimity
